Approval of disapplication of pre-emption rights

Dear Fellow Shareholder,

During the year ended 30 June 2024, Avation achieved 100 per cent. fleet utilisation for the first time since early 2020. As set out in the Company's Annual Report (available on the Company's website), the 2024 financial results show the Company's continued progress in reducing its debt and the de-levering of its balance sheet. The Company is optimistic about a future for the leasing industry characterised by high demand for aircraft as the global fleet builds and transitions to low CO₂ technology in the coming years.

In the financial year ended 30 June 2024, Avation increased its profitability, increased net asset value per share, maintained liquidity, materially lowered net indebtedness and returned to a growth strategy.

The market for air travel has continued to perform strongly with IATA reporting record passenger volumes in their latest air passenger market analysis report. Industry RPKs (Revenue Passenger Kilometres, a key metric) grew 8.0 per cent. in the year to July 2024 led by international travel with 10.1 per cent. growth followed by domestic travel with 4.8 per cent. growth.

Avation has continued to reduce debt and de-lever its balance sheet, achieving a reduction to 57.0 per cent. in the ratio of net debt to total assets as at 30 June 2024. A significant portion of the cashflow generated by the fleet is directed towards repayments of debt. Scheduled loan repayments for the 2025 financial year, amount to around US\$49.7 million, which exceeds the expected depreciation of the fleet over the same period. The Company is hedged against further interest rate changes on 96.4 per cent. of its loans and borrowings.

Avation plans to grow its business in a prudent and strategic manner. To that end the Company has placed an order for ten new ATR 72-600 aircraft to be delivered gradually over the period from Q4 2025 to Q2 2028. Avation's management believe that the contract price for this order is favourable compared to forward valuations for the aircraft type. The order was placed by exercising ten of the Company's purchase rights for new ATR aircraft. On placement of the order Avation was granted an additional six purchase rights and the expiry date for all purchase rights was extended to 2034. Avation now holds 24 purchase rights for new ATR 72 aircraft. All of the ordered aircraft will be equipped with the new PW127-XT engine variant, which the manufacturer currently expects will be approved for use with sustainable aviation fuel during 2025. ATR is the world's number one regional aircraft manufacturer and offers the lowest-emissions regional aircraft.

Avation's long-term strategy is to target growth and diversification by adding new airline customers, while maintaining a low average aircraft age and long remaining lease term metrics. Avation focuses on new and

relatively new commercial passenger aircraft on long-term leases. In the short term the Company is considering further growth in its narrow body fleet.

Sources of Finance

We continue to evaluate the mix of financing required to optimise the Company's capital structure. When appropriate, equity funding from the issue of new share capital in the Company remains an important component in funding the Company's growth. The directors believe the Company has a proven track record in generating a return on contributed capital over the longer term. Accordingly, the Notice of AGM contains resolutions enabling the directors to issue equity securities as described below. It is recommended that Shareholders support these resolutions.

Resolution 7 will be proposed as an ordinary resolution to provide the directors with authority to allot relevant securities (within the meaning of the Companies Act 2006 (the **CA 2006**)) up to an aggregate nominal amount of £150,000 enabling the directors to allot up to 15 million new ordinary shares which represents approximately 21 per cent. of the Company's issued and agreed to be issued share capital as at the date of this Notice.

In order to provide the directors with the power to allot equity securities (as defined by section 560 of the CA 2006) for cash without first offering those equity securities to Shareholders in accordance with section 561(1) of the CA 2006, Resolution 9 (which is subject to Resolution 7 being passed) will be proposed as a special resolution to provide the directors with authority to allot equity securities as if section 561(1) of the CA 2006 did not apply to such allotments up to a maximum nominal amount of £50,000, being a maximum of 5 million new ordinary shares, which represents approximately 7 per cent. of the Company's issued and agreed to be issued share capital as at the date of this Notice.

Use of Proceeds

The Directors confirm their intention that any cash raised by the Company from non-pre-emptive issues of equity securities pursuant to Resolution 9, should they occur, will be used to fund business matters such as:

- the purchase of aircraft, repayment of debt, general working capital; and
- the maintenance of adequate debt to equity ratios,

in each case, where the Board believes such transactions would be in the best interests of the Company and its Shareholders. Detailed use of proceeds information would be provided in the context of any specific proposal to issue equity securities.

Recruitment and retention of management and staff

As the Company grows, the recruitment and retention of experienced executives are key to underpinning the continued growth of the Company's business. The Company has adopted a remuneration policy with the following principles aimed to assist in attracting and retaining suitably skilled executives and staff:

The policy is designed so as to:

- provide a fair and transparent remuneration policy that is in alignment with Shareholders' interests;
- provide both immediate and incentive remuneration that is sufficient to attract and retain employees within the current market;
- be consistent with market practices for listed companies;
- allow claw-back of incentives should previous performance be found to have led to future adverse circumstances for the Company; and
- ensure alignment between performance and compensation.

Part of the incentive mix will be the grant of options and/or warrants to members of staff, and such grants are overseen by the Company's board of directors.

Resolution 9(b) therefore further seeks to dis-apply pre-emption rights to enable directors to grant options and/or warrants to subscribe for shares with a nominal value in aggregate of up to £25,000, representing 2.5 million new ordinary shares (representing approximately 3.5 per cent. of the Company's issued and agreed to be issued share capital as at the date of this Notice), in each case in accordance with the Company's remuneration policy and any employee share option scheme as adopted by the directors from time to time.

Recommendation

The directors consider that the passing of the resolutions is likely to promote the success of the Company and is in the best interests of the Company and its Shareholders as a whole.

Accordingly, the Board unanimously recommends that Shareholders vote in favour of the resolutions to be proposed at the Annual General Meeting. - (a) not exceed in aggregate 25 per cent. of the total number of Shares as at the date of the passing of this resolution;*
- (b) be at such price or prices as may be determined by the directors from time to time (but not under £0.75 per Share and not exceeding an amount equal to the higher of (i) 105 per cent. of the average of the middle market quotations for the ordinary shares of the Company as derived from the Daily Official List of the London Stock Exchange plc for the five business days immediately preceding the day on which such share is contracted to be purchased; and (ii) the value of an ordinary share calculated on the basis of the higher of the price quoted for: (a) the last independent trade and; (b) the amount stipulated by Regulatory Technical Standards adopted by the European Commission pursuant to Article 5(6) of the Market Abuse Regulation (EU) No. 596/2014 and, in any case, not exceeding £2.00 per share, excluding brokerage, commission, applicable goods and services tax, stamp duty and other related expenses); and*
- (c) be transacted through one or more duly licensed stockbrokers appointed by the Company for the purpose and otherwise in accordance with all other laws, regulations and rules of the relevant securities market as may for the time being be applicable,*

and further provided that the authority conferred by the passing of this resolution shall expire at the conclusion of the Company's next annual general meeting but a contract of purchase may be made before the expiry which will or may be completed wholly or partly thereafter, and a purchase of Shares may be made in pursuance of any such contract.

EXPLANATORY NOTES TO THE PROPOSED RESOLUTIONS

Resolution 1 – Report and Accounts

The directors are required by company law to present the financial statements, the directors' report and the auditors' report on the financial statements to the meeting.

Resolution 2 – Remuneration Report

Shareholders are asked to approve the remuneration report, a copy of which is set out in the Annual Report.

Resolution 3 – Re-election of Mr Robert Jeffries Chatfield as Director

Mr Chatfield is Executive Chairman of the Company and was a founding director, appointed on 11 July 2006. Mr Chatfield was appointed as the director of Skywest Airlines Ltd. on 19 December 1997 and served as the Executive Chairman of Skywest Airlines Ltd. until its takeover by Virgin Australia Holdings Limited on 11 April 2013.

Mr Chatfield has managed and been a director of a number of companies involved in the airline, data distribution, electronics, investment, broadcasting and manufacturing sectors. He is the author of a variety of patents held by Avation and its subsidiaries. He graduated from Hale Secondary Education High School in year 1981 and obtained a Master of Engineering Science from University of Western Australia in year 1992. He was also conferred with Bachelor's and Master's Degrees by the School of Engineering, University of Western Australia and awarded the prize for the highest pass marks in the final year of his Bachelor's Degree. In year 2016, he attended a Financial Market Course in Yale University as well. He is a graduate member of the Australian Institute of Company Directors and a member and fellow of the Singapore Institute of Directors. He was born in Perth, Australia and is a Permanent Resident of Singapore.

Resolution 4 – Re-election of Roderick Douglas Mahoney as Director

Mr. Mahoney served as Chief Operating Officer and Chief Commercial Officer of the Company for 10 years and retired from executive duties in 2022. Prior to that, Mr. Mahoney was a fleet planning and aircraft procurement consultant to the Group and has previously been a project advisor to a variety of Asia-Pacific airlines, suppliers and other aviation businesses, including Virgin Blue and V Australia. Before that, he held various senior executive positions at Airbus for 23 years, largely within the sales divisions covering Europe and Africa, China and the Pacific. He holds a Bachelor of Science Degree in Aeronautical Engineering, a Masters Degree in Air Transport from Cranfield Institute of Technology and a Masters of Applied Finance Degree from Macquarie University in Sydney. He is a Graduate Member of the Australian Institute of Company Directors and a member of the Singapore Institute of Directors. Mr. Mahoney was born in Hawick, Scotland and resides in Sydney, Australia.

Resolution 5 – Re-appointment of Auditors

The Company is required at each general meeting at which financial statements are laid to appoint auditors who will remain in office until the next general meeting at which financial statements are laid. Messrs Ernst & Young have expressed their willingness to be appointed as auditor for the coming year.

Resolution 6 – Remuneration of Auditors

In accordance with company law and good corporate governance practice, Shareholders are asked to authorise the directors to determine the auditors' remuneration.

Resolution 7 – Authority to Allot Shares (General)

This resolution would give the directors' authority to allot new shares. The authority, if approved, will expire on the date of the 2025 annual general meeting. The authority will allow the directors generally and unconditionally to allot shares in the Company and to grant rights to subscribe for or convert any security into shares in the Company up to an aggregate nominal amount of £150,000 enabling the directors to allot up to 15 million new ordinary shares which represents approximately 24 per cent. of the Company's issued

and agreed to be issued share capital to such persons and at such times and on such terms as the directors think fit.

Resolution 8 – Final Dividend

The directors have proposed a final dividend for the financial year ending 30 June 2024 of 0.5 pence per ordinary share. The proposed dividend timetable is as follows:

- Ex-dividend date: 28 November 2024
- Record date: 29 November 2024
- Payment date: 23 December 2024

As a final dividend, it must be approved by shareholders and this resolution will enable the Company to make the dividend payment as set out above.

Resolution 9 – Disapplication of Pre-Emption Rights (General)

If the directors wish to allot new shares (and other equity securities), or sell treasury shares, for cash, the Companies Act 2006 requires that these shares are offered first to Shareholders in proportion to their existing holdings. These rights are known as pre-emption rights. There may be occasions, however, when, in order to act in the best interests of the Company, the directors will need the flexibility to finance business opportunities by the issue of shares without a pre-emptive offer to existing Shareholders. This resolution would give the directors the power to allot shares for cash without first offering them to existing Shareholders in proportion to their existing holdings. The resolution would limit any allotment in respect of non pre-emptive offers to an aggregate nominal amount of £50,000 equal to 5 million ordinary shares, representing approximately 7 per cent. of the issued and agreed to be issued share capital. The disapplication of pre-emption rights would expire at the conclusion of the next annual general meeting.

Resolution 10 – Share Buy Back Mandate

This resolution seeks authority for the Company to make market purchases of its own ordinary shares. If passed, the resolution gives authority for the Company to purchase shares representing up to 25 per cent. of its ordinary shares in issue as at the date of the passing of the resolution (excluding treasury shares). The directors will only exercise the authority to purchase ordinary shares where they consider that such purchases will be in the best interests of Shareholders generally and will result in an increase in earnings per ordinary share.

Resolution 11 – Disapplication of Pre-emption Rights (Treasury Shares)

This resolution would give the directors the power to sell treasury shares for cash without first offering them to existing Shareholders in proportion to their existing holdings. The disapplication of pre-emption rights would expire at the conclusion of the next annual general meeting. The Company does not intend to sell treasury shares at a discount of more than 10 per cent. to the middle market price of those shares at the time of announcing the terms of the sale.

PROCEDURAL NOTES TO NOTICE OF ANNUAL GENERAL MEETING

1. A member of the Company entitled to attend and vote at the AGM may appoint a proxy or proxies to attend and to speak and vote instead of him. A member may appoint more than one proxy in relation to the AGM provided that each proxy is appointed to exercise the rights attached to a different share or shares held by that member. A proxy need not be a member of the Company.
2. The attached form of proxy for use at the AGM should be completed, signed and returned to the Company's registrars (the **Registrars**) at The Registrar, Computershare Investor Services PLC, The Pavilions, Bridgwater Road, Bristol BS99 6ZY, United Kingdom (if the form is posted outside the United Kingdom, you should return it in an envelope specifying "par avion" (airmail) using the Registrars' address above). It must arrive no later than 9.00 a.m. (UK time) on 17 December 2024. Completion and return of the form of proxy will not prevent a shareholder from subsequently attending the meeting and voting in person if they so wish.
3. To be effective, the instrument appointing a proxy, and any power of attorney or other authority under which it is signed (or a copy of any such authority certified notarially or in some other way approved by the directors), must be deposited with the Registrars at The Registrar, Computershare Investor Services PLC, The Pavilions, Bridgwater Road, Bristol BS99 6ZY, United Kingdom no later than 9.00 a.m. (UK time) on 17 December 2024 (or 9.00 a.m. (UK time) on the day two days prior to an adjourned meeting) or, in the case of a poll taken more than 48 hours after it is demanded, not less than 24 hours before the time appointed for the taking of the poll at which it is to be used.
4. In the case of joint holders, the vote of the senior who tenders the vote shall be accepted to the exclusion of the votes of the other joint holders and for this purpose, seniority shall be determined by the order in which the names stand in the Register of Members of the Company.
5. All members are entitled to attend and vote at the AGM and ask questions. Under section 319A of the Companies Act 2006 (**CA 2006**), the Company must answer any question you ask relating to the business being dealt with at the meeting unless: answering the question would interfere unduly with the preparation for the meeting or involve the disclosure of confidential information; the answer has already been given on a website in the form of an answer to a question; or it is undesirable in the interests of the Company or the good order of the meeting that the question be answered.
6. Pursuant to regulation 41 of the Uncertificated Securities Regulations 2001, the Company has specified that to be entitled to attend and vote at the AGM (and for the purpose of determining the number of votes they may cast), members must be entered on the register of members of the Company by 6.00 p.m. (UK time) on 17 December 2024. If the meeting is adjourned then, to be so entitled, members must be entered on the register of members of the Company at 6.00 p.m. (UK time) on the day two days before the time fixed for the adjourned meeting, or, if the Company gives notice of the adjourned meeting, at any other time specified in that notice.
7. Under section 527 of the CA 2006, members meeting the threshold requirements set out in that section have the right to require the Company to publish on a website a statement setting out any matter relating to: (i) the audit of the Company's accounts (including the auditors' report and the conduct of the audit) that are to be laid before the AGM; or (ii) any circumstances connected with an auditor of the Company ceasing to hold office since the previous meeting at which annual accounts and reports were laid in accordance with section 437 of the CA 2006. The Company may not require the shareholders requesting any such website publication to pay its expenses in complying with section 527 or 528 of the CA 2006. Where the Company is required to place a statement on a website under section 527 of the CA 2006, it must forward the statement to the Company's auditors not later than the time when it makes the statement available on the website. The business which may be dealt with at the AGM includes any statement that the Company has been required under section 527 of the CA 2006 to publish on a website.
8. Any person to whom this notice is sent who is a person nominated under Section 146 of the CA 2006 to enjoy information rights (a **Nominated Person**) may, under an agreement between him and the member by whom he was nominated, have a right to be appointed (or to have someone else appointed) as a proxy for the meeting. If a Nominated Person has no such proxy appointment right or does not wish to exercise it, he may, under any such agreement, have a right to give instructions to the member as to the exercise of voting rights. The statement of the rights of members in relation to the appointment of proxies in paragraph 1 above does not apply to Nominated Persons. The right described in that paragraph can only be exercised by members of the Company.
9. If the Chairman, as a result of any proxy appointments, is given discretion as to how the votes which are the subject of those proxies are cast and the voting rights in respect of those discretionary proxies, when added to the interests in the Company's securities already held by the Chairman, result in the Chairman holding such number of voting rights that he has a notifiable obligation under the Disclosure Guidance and Transparency Rules, the Chairman will make the necessary notifications to the Company and the Financial Conduct Authority. As a result, any member holding 3 per cent. or more of the voting rights in the Company who grants the Chairman a discretionary proxy in respect of some or all of those voting rights and so would otherwise have a notification obligation under the Disclosure Guidance and Transparency Rules, need not make separate notification to the Company and the Financial Conduct Authority.
10. As at 15 November 2024 (the latest practicable date prior to the publication of this document), the Company's issued ordinary share capital consisted of 70,878,124 ordinary shares. As at that date the Company held no ordinary shares in treasury. Treasury shares are not taken into consideration in relation to the payment of dividends and voting at shareholder meetings. Accordingly, there are a total of 70,878,124 voting rights available for the purpose of calculating shareholders' percentage voting rights.
11. Any corporation which is a member can appoint one or more corporate representatives who may exercise on its behalf all of its powers as a member provided that they do not do so in relation to the same shares.

12. Shareholders and any proxies or representatives they appoint understand that by attending the meeting that they are expressly agreeing that they are willing to receive any communications, including communications relating to the Company's securities, made at the meeting.
