TRANSACTION IN OWN SHARES AND TOTAL VOTING RIGHTS

Aviation PLC (LSE: AVAP), the commercial passenger aircraft leasing company, announces that on 22 January 2026 it repurchased 100,000 ordinary shares through the market at a price of 141.8p per share. The repurchased shares will be held in treasury. There are 66,835,066 ordinary shares in issue with 4,483,999 held in treasury. Total voting rights are now 62,351,067.

This transaction is conducted pursuant to Aviation's approved share buyback programme, which authorises the repurchase of up to 25% of its issued share capital, under a mandate approved at the annual general meeting in November 2025. The authority allows Aviation to buy shares in the market within specified price limits until the conclusion of its next annual general meeting.
