TRANSACTION IN OWN SHARES AND TOTAL VOTING RIGHTS

The Board of Avation PLC (LSE: AVAP), announces that on 30 April 2025 it repurchased 20,000 ordinary shares, through the market, at a price of 150 pence per share. The repurchased shares will be held in treasury.

There are now 74,950,257 ordinary shares in issue with 8,275,000 shares held in treasury. The total number of voting rights in the Company is therefore 66,675,257. This figure may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in the Company under the FCA's Disclosure Guidance and Transparency Rules.
